was Dick Godbehere, who was, prior to being
Sheriff of the fourth largest county in the
United States, literally a lawn mower repairman.
No, I kid you not. And he served with the same
level of sophistication you would expect of a
lawn mower repairman.

Then came Tom Agnos, who was supposed to return “professionalism” to the Maricopa County Sheriff’s Office (MCSO). But Agnos was a subservient Sun City resident who led the MCSO into not just the biggest cock-up in Maricopa county law enforcement history, but one of national and international proportion. The Buddhist Temple Murder Case where nine buddhist monks and acolytes were lined up and shot in the back of the head, execution style, at the Wat Promkunaram Buddhist Temple on the west side of Phoenix.

It was out of the Buddhist Temple Murders Joe Arpaio came to be. A group of prominent Phoenix trial attorneys, both criminal and civil, wanted an alternative to Tom Agnos and the whitewashing coverup he was conducting on one of the greatest coerced false confession cases in world history. The group of trial lawyers coalesced around the upstart primary candidacy of a local travel agent with a colorful background. Yep, one Joseph Arpaio.

Joseph Arpaio promised that initial group of trial lawyers he would clean up the MCSO, release the damning internal report of the gross misconduct that had occurred in the Temple Murder Case under Tom Agnos, which lead to at least four false and heinously coerced confessions, and that he would refuse, under all circumstances, to serve more than one term in office. It was a promise made and, obviously, a promise long ago broken.

To be fair, Arpaio did release the internal report on the Temple Murder



Case, which led to five plus million dollar settlement for some of the most wrongfully arrested souls in American history. But with that promise kept within a short time of taking office, Joe Arpaio breached the solid promise he made to the people who gave him the seed funding carrying him into office. And Arpaio has made a mockery of his word, as a man, ever since by repeatedly running for office and sinking Maricopa County into depths of depravity and fiscal distress beyond comprehension, from the vantage of the MCSO.

Arpaio's false pretenses to get elected have turned into the fodder of liability for the county he was supposedly elected to serve and protect.

How deep has Arpaio's liability effected the taxpayers, and residents, of Maricopa County? To the tune of at least \$50 Million dollars. AT LEAST. Because that figure not only does not count the costs of defense, and they are usually astronomical in the larger cases against Arpaio, because he never admits responsibility, but also does not consider Maricopa County is self insured and may not, necessarily, publicly disclose all smaller payouts. There may, or may not, be a lot more payout, or a lot more, we just don't know.

So, what is the ledger to date? Here it is in all its sick glory. \$50 Million dollars of unnecessary payout, all because of a man, who promised, and who was initially sponsored, and brought to election, by a group who wanted change and the diametric opposite of what came to be.

Here is the worse part: the \$50 Million figure is, by all appearances, devoid of the real and hard actual costs of defending all the action on which payout was made in that spreadsheet. Hard costs are known in the legal world as attorney fees, court costs, expert witness fees, service costs, evidentiary laboratory fees – in short, fees that can add up to millions in, and among, themselves, irrespective of the underlying root

liability payouts. In short, the \$50 Million you see in the ledger is but a fraction of the real cost of Joe Arpaio's criminally and civilly negligent insolence as Sheriff of Maricopa County. Nor does the figure, of course, include the losses that already should have come from the Deborah Brailard case, much less the Matty Atensio case.

Who is Matthew Atensio represented by? That would be by one prime example of tort liability counterbalance to egregious wrongdoing, Michael Manning. Who is Michael Manning? Well, Manning is the grinning man in the photograph above, with the somewhat soullessly dumbfounded Joe Arpaio at a charity fundraiser. Manning has a right to grin at the sight of the "Toughest Sheriff In America", because Michael Manning, alone, has taken the greatest portion of the nearly \$50 Million (and very much increasingly counting) toll on the taxpayers of Maricopa County, the narcissistic propaganda obsessed figurine Joe Arpaio has cost. And Manning and fellow Phoenix attorney Joel B. Robbins, have laid the wood to Sheriff Joe, and the worst is yet to com in the form of the Atensio litigation and other compelling cases (not to mention Brailard which should have settled and, now, instead awaits a larger jury verdict on already determined damages).

You think the moral and tort liability train fueled and paid by the taxpayers and citizens of Maricopa County has sailed into the sunset? Oh no. There are mountains of liability and taxpayer's coffer's payouts on the horizon. The only question is if the residents and voters of Maricopa County will wake up and end the madness now, or whether they will give yet another term of office to the Most Liable and Wasteful Sheriff In American History".

The dedicated folks at "Adios Arpaio" have done yeoman's work in identifying, registering, and encouraging tens of thousands, if not more of, not just latino, but voters of all colors and stripes, to vote in this election. A heroic

effort.

But where does that leave the citizens of Maricopa County? Arguably still short against the self promoting dynamo that is Sheriff Joe Arpaio. It is a living monument to the benign destruction caused by hyped belligerence, ignorance and apathy in a designated and restricted electorate. Joseph Arpaio came into office as the the promised one term agent of well meaning, and will leave, to the shame of Maricopa County as perhaps the most disgraceful official ever elected in the county. RICK SCOTT, FLORIDA REPUBLICAN LEGISLATURE USED BLATANTLY PARTISAN TACTICS TO SUPPRESS DEMOCRATIC VOTES

Florida Governor Rick Scott has done his best to prevent Democrats voting in the 2012 Presidential Election. First, Scott and his Republican legislature undertook a purge of Florida’s voting lists that was so biased against minorities (who tend to vote Democratic) that the state was sued by the Department of Justice for violating the National Voter Registration Act. The purge was so overly aggressive that there are now reports of multiple military personnel being disenfranchised by the State of Florida for the 2012 election. In addition, Scott and his Republican co-conspirators in the legislature dramatically cut back on early voting hours in Florida.

Marc Caputo of the Miami Herald has been following voting issues in Florida closely. He has posted the results for how many Floridians voted early this year, as seen in the table [here](#).

Note that Democrats had a very much larger turnout than Republicans for early voting but Republicans had the advantage in absentee voting.

Caputo noted that the changed law for 2012 cut early voting hours back from 14 days to 8 days. However, Floridians responded to the cutback by turning out in almost as big numbers and despite waits of 8 hours or more at some locations, there were 2.4 million early votes this year compared to 2.6 million in 2008.

One of Caputo's most important observations about the changes in Florida's voting laws concerns the relative treatment of early voting and absentee voting:

Guess which type of voting Republicans specialize in? Absentee ballots. Democrats do better at in-person early voting. Though more fraud-prone, absentee ballot voting wasn't touched in the election law Scott signed that shortened early voting days.

What? Fraud in a type of voting Republicans

prefer? Yes, there are major vote fraud cases of absentee ballot fraud going on from the very northern part of the state in Madison County to the south in Miami-Dade County. But of course, despite claiming that their voter roll and early voting hour changes were aimed at assuring a fair election free of fraud, Scott and his lackeys left untouched the easiest route to fraud, which just so happens to also be the form of pre-election voting that their side prefers. Their moves now stand as a clear indicator that Florida's Governor and legislature have no qualms about suppressing the votes of their opponents while enabling fraud on their own side.

We can only hope that the people of Florida wake up to these disgusting tactics before voting in the 2014 gubernatorial election.

Chris Christie can be forgiven for boosting up Obama's image as President the last week of the campaign. After all it makes him look Presidential. More importantly, it'll ensure NJ gets lots of quick federal attention. (Though it did remind me that Christie used his coming out party at Mitt's RNC to talk about Chris Christie.)

Ryan's allies aren't ruling out a bid for the top spot for their friend.

5 mentions of the next Presidential cycle, about a guy who's on the ticket for this cycle.

And finally there's this "accidental" email sent by Newt's people:

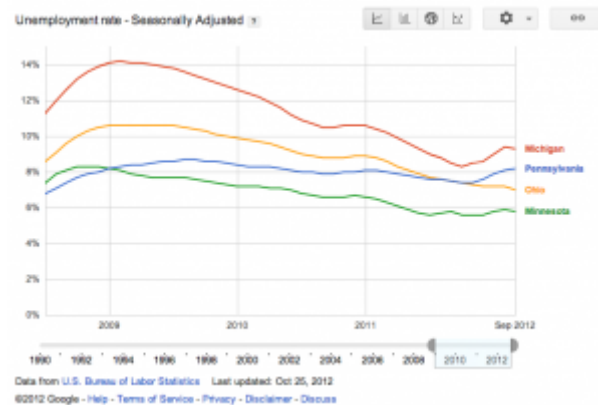
"The truth is, the next election has already been decided. Obama is going to win. It's nearly impossible to beat an incumbent president," advertiser Porter Stansberry wrote in the email to Gingrich supporters. "What's actually at stake right now is whether or not he will have a third-term."

You gotta get an early start, I guess, if you'll be 73 when you run again.

It's all rather ghoulish, this campaigning to take over Mitt's position as the party's standard bearer before the race has even been called.

I don't feel all that bad for Mitt, though. After all, he has participated in the weird custom of posthumously baptizing people, basically converting people after they're dead. Republicans, apparently, follow the opposite strategy, burying you while you're still technically alive.

CREEPING UNEMPLOYMENT IN THE NEW BATTLEFIELDS: PA AND MI



The big news of the campaign, once you get beyond Mitt's

kabuki storm assistance and auto bashing, is that PA and MI are battlegrounds again.

Maybe.

First, Restore Our Future PAC announced \$2 million ad buys in both states. The the Obama campaign announced they'd buy ads as well.

Today, the Detroit News has a poll showing Mitt within 2.7% of Obama (though polling ended on the 29th, when Mitt's deceitful auto binge began). In fact, while Romney and Ryan were "not campaigning" yesterday, Ann Romney was, here in Grand Rapids.

Some commentators suggest this is just Mitt's

effort to open up new battlegrounds as it becomes clear he won't win OH and might not win VA (or FL, but that would be game over for him). That is, Mitt has to look viable, and by moving into MI and PA, he can sustain narratives that he still has a shot.

That may be what's going on.

But it pays to look at what has been going on with the unemployment rate in both MI and PA (I've included OH for comparison and MN because it often gets thrown into these discussions).

MI's unemployment rate is up 1% off its recent low in April (the downtick this month, and some of last month's uptick, is probably due to the way the auto companies handled model year layoffs). Part of the uptick is probably due to Rick Snyder's austerity plans; part is probably due to Obama's failure to provide real mortgage relief.

PA's unemployment rate is up .8% from its recent low in May. Here, too, Republican governor Tom Corbett has pursued austerity measures. In addition, PA is exposed to the Euro-related decline that has hurt much of the Northeast.

The point, though, is that both these states have the makings of a battleground state—including a white working class population that can swing with economic tides—plus rising unemployment. Obama is still ahead in both. A few more ads about the auto bailout—indeed, Mitt's deceitful attacks on GM and Chrysler generally—will probably move MI back towards Obama. And the Philadelphia area was spared the worst of Sandy, staving off the possibility that Pennsylvania would have unimpeded voting while the Democratic Southeast would have floods. So it's still most likely Obama will win both by comfortable margins.

But one thing makes movement towards Mitt more realistic here than in, say, MN. The economy is getting worse again. And in spite of all Mitt's unforced errors in recent days, and in spite of the way that Snyder and Corbett's state level

policies—which mirror those Mitt would adopt at the federal level—have almost certainly exacerbated unemployment, voters may still turn to Mitt as an alternative to a stalled recovery.

Mitt's play in MI and PA is probably a ploy to look viable. But there are a lot of unemployed workers in both states who will help him along.

WHY DOES MITT HATE PROFIT?

[I posted substantially this post yesterday, but the BlogGods ate it along the way. So I'm reposting.]

Along with the deceitful attack on Italians who make better car company owners than GOP Private Equity types and the Lee Iacocca spin, Mitt has rolled out a radio version of attack on the auto bailout. From Greg Sargent, here's part of the script:

Barack Obama says he saved the auto industry. But for who? Ohio, or China? Under President Obama, GM cut 15,000 American jobs. But they are planning to double the number of cars built in China – which means 15,000 more jobs for China.

And now comes word that Chrysler plans to start making jeeps in – you guessed it – China. What happened to the promises made to autoworkers in Toledo and throughout Ohio – the same hard-working men and women who were told that Obama's auto bailout would help *them*?

The ad continues Mitt's deceptive insinuation that GM and Chrysler aren't also adding jobs in the US, which they are doing.

But it does something else. It takes a decidedly anti-profit stance.

You see, there are two reasons car companies are so gung-ho to enter (or re-enter, in the case of Jeep) the Chinese market. First, because it's growing; when I was working in China, auto people considered the rising Chinese middle class to be 300 million—almost an entire US full of population. And most of them were just aspiring to buy their first car. That's a whole lot of first time car buyers to sell to, as compared to US consumers, who are driving less and replacing their cars at a slower pace given more durable cars.

The other reason to go to China? Profit margins are bigger there than here. When I was in Shanghai in the mid-2000s, the profit margin on Buick Regals was about \$2,000, as compared to the roughly \$200 profit margin on a similar car here. The margins are closer now (because manufacturing in the US has gotten cheaper and in China has gotten more expensive), but China still offers good profit margins. Selling Buick Regals or Jeeps in China allows GM and Chrysler to accept lower margins on cars here.

By selling high margin cars in China, US companies can be more competitive here, meaning they will be able to expand sales and therefore production here, too.

All this is implicit in Sergio Marchionne's response to Mitt's ignorant rantings.

Together, we are working to establish a global enterprise and previously announced our intent to return Jeep production to China, the world's largest auto market, in order to satisfy local market demand, which would not otherwise be accessible. Chrysler Group is interested in expanding the customer base for our award-winning Jeep vehicles, which can only be done by establishing local production. This will ultimately help bolster the Jeep

brand, and solidify the resilience of U.S. jobs.

Marchionne notes 1) you can't sell in China unless you build in China, 2) selling in China makes the Jeep brand stronger, 3) making the Jeep brand (and its profit margins) stronger makes it easier to keep up US production.

Marchionne's implicit point should be where this discussion is heading: free trade hasn't worked out to be fair trade. China—and Japan and Korea—still protect their markets, meaning if you want to sell there, you've got to make cars there.

Mitt has promised to get tough on China. But his series of auto ads have made no mention—not a peep!—of how he'll reverse this practice and make it possible for Jeep to export cars made in Toledo. Indeed, when Obama launched a trade dispute over auto parts in September, Mitt scoffed at the effort (and ignored Obama's decent and sustained effort launching trade disputes, one of which pertaining to specialty steel recently won at the WTO).

“The president may think that announcing new trade lawsuits less than two months before the election will distract from his record, but American businesses and workers struggling on an uneven playing field know better,” Mr. Romney said in a speech to the Hispanic Chamber of Commerce in Los Angeles.

Mitt Romney wants to attack American companies for going where profits are. And he's doing so without discussing why that's necessary.

That makes him neither a tough guy nor a good businessman.

LEE IACocca: MITT WILL MAKE IT EASIER FOR AUTO COMPANIES TO EVADE TAXES ON CARS BUILT IN CHINA

As part of its effort to pretend that Mitt would be good for the auto industry, the campaign had Lee Iacocca sum up why Mitt would be good for the auto industry.

The first paragraph of specifics reads:

When Mitt Romney is president, he will reduce our nation's corporate tax rate to 25 percent from 35 percent – currently the highest combined tax rate in the industrial world – so that American car companies can compete on a level playing field at home and abroad. He will also stop the extra tax automakers are forced to pay when they want to bring home their profits to reinvest in the United States. President Obama could have done this the day he took office since his party controlled both houses of Congress, but he chose not to. [my emphasis]

Obama, of course, has a tax credit specifically for manufacturing companies, meaning under Obama the auto companies would pay less than under Mitt.

But the other part—particularly against Mitt's egregious claims that the auto bailout has helped Chrysler and GM move production overseas—is even more ridiculous.

Iacocca says Mitt would be better for the auto companies because he'd allow the auto companies to repatriate profits from overseas without paying taxes.

But that assumes, of course, they're making profits overseas. It would mean they were doing precisely the thing Mitt is attacking—moving into new markets, like China.

So on the same day Mitt attacks Chrysler and GM for making and selling cars in China, generating greater profit it can use to support workers here, his campaign sends out a post boasting that Mitt would require Chrysler and GM to contribute less domestically on the profits they made by making and selling cars in China.

I've been a bit tardy in responding to Mitt's latest cynical ploy, to pretend that rather than expanding production and jobs in both OH and MI, Chrysler is outsourcing production to China.

The Detroit News' David Shepardson has a good fact check on Mitt's latest ad here. Greg Sargent rounds up OH papers mocking Mitt's claims here.

But there's an angle on Mitt's claims that has been missed. His ad says,

Obama ... sold Chrysler to Italians who are going to build Jeeps, in China.

As Shepardson notes, Chrysler used to build Jeeps in China for the Chinese market. Ford builds cars in China for the Chinese market. GM

builds cars in China for the Chinese market (GM also exports Chinese-built subcompacts to Latin America). Chrysler's return to the world's largest car market is smart business, something any viable global brand needs to do.

If it's a moral failing for Presidents to preside over private car companies trying to compete in China, then Mitt has a problem with St. Reagan, during whose Administration Jeep first made groundbreaking entries into the Chinese market.

And if Mitt has a problem with Chrysler (or Ford or GM) building cars in China to sell in China, then he had better prepare to get far tougher with China than he has threatened to do so far. China still slaps huge tariffs on cars made outside of the country, so to be viable in the world's largest automotive market, you have to build in China. That is the crux of the argument American car companies (and Midwestern politicians) have been making for decades: while the US allows imports from all countries, Japan and Korea and now China make it very difficult to export to those countries. This is not fair trade.

But I'm most offended by Mitt's insinuation that selling Chrysler to an Italian company—he doesn't mention Fiat by name—was disloyal.

Recall Chrysler's recent history. Chrysler's most recent strong point was the early 2000s, when it succeeded in developing nifty (albeit gimmicky) cars with shortened development cycles (think PT Cruiser). But as Daimler took more control over Chrysler, it invested less in the brand. GOP Private Equity firm Cerberus bought its first 80% of the company in 2007 and picked up the rest in 2009.

Cerberus had no intention of bringing Chrysler back to its former strength. Rather, it wanted to strip out the finance side of the company (it was investing in GMAC at the same time) and sell off the rest. But with the impending financial crisis, it never managed to pull off the trick

(though it did get a bank bailout in the very last days of the Bush Administration). Meanwhile, it virtually put the Chrysler model development on autopilot while it tried to find a way to cut its losses.

Thus, when it came time for bailouts, there didn't seem much to bail out at Chrysler. Unlike GM, which really had started making a turnaround, Chrysler had no product in the pipeline to suggest it would be worth bailing out (though it did have a few super efficient factories in the US).

Choosing to bailout Chrysler was the most difficult decision Obama made during the auto bailout. I'm not even sure I would have chosen to bail it out. And it was difficult precisely because a bunch of Republican vulture capitalist types—people like former VP Dan Quayle and former Treasury Secretary John Snow—had stripped the company.

In came Fiat and its Steve Jobs-like CEO Sergio Marchionne. As it scrambled to start filling the Chrysler product pipeline again, it kept up the brand—and sales—with the kind of compelling advertising not seen from an American car company in decades. That bought it time to bring in Fiat's own popular cars—like the 500—and start making Chrysler back into a car—rather than finance—company.

And it's working. Today, Chrysler announced profits up 80%.

Chrysler Group LLC posted an 80 percent rise in quarterly net income on Monday on stronger new vehicle sales, continuing the U.S. automaker's comeback from its 2009 bankruptcy.

Chrysler, majority owned by Italy's Fiat SpA (FIA.MI), also reaffirmed its outlook for the year. Fiat will issue its earnings on Tuesday.

Net income in the third quarter rose to \$381 million from \$212 million a year earlier. Net revenue increased 18 percent to \$15.48 billion.

Globally, Chrysler's auto sales rose 12 percent to 556,000 vehicles in the quarter.

"We've changed the conversation at Chrysler Group," said Sergio Marchionne, chief executive of both Chrysler and Fiat.

Mitt Romney may disdain the Italian company that focused Chrysler on making cars again. But the comparison couldn't be more stark. Cerberus—a bunch of GOP PE guys that differ from Bain Capital not in philosophy but probably in IQ—ran Chrysler into the ground as it tried to strip everything but the finance out of the company. Fiat came in and started building cars again.

And now, as it returns to viability, it's entering back into the Chinese market the way almost every other company does: by building in China.

That's a success story. But Mitt, I guess, would like to bring Chrysler back to the PE approach of stripping the company rather than building it up.

Update: Marchionne refutes Mitt's bullshit:

We also are investing to improve and expand our entire U.S. operations, including our Jeep facilities. The numbers tell the story:

- *We will invest more than \$1.7 billion to develop and produce the next generation Jeep SUV, the successor of the Jeep Liberty – including \$500 million*

directly to tool and expand our Toledo Assembly Complex and will be adding about 1,100 jobs on a second shift by 2013.

- *At our Jefferson North Assembly Plant, where we build the Jeep Grand Cherokee, we have created 2,000 jobs since June 2009 and have invested more than \$1.8 billion.*
- *In Belvidere, where we build two Jeep models, we have added two shifts since 2009 resulting in an additional 2,600 jobs.*

With the increase in demand for our vehicles, especially Jeep branded vehicles, we have added more than 11,200 U.S. jobs since 2009. Plants producing Jeep branded vehicles alone have seen the number of people invested in the success of the Jeep brand grow to more than 9,300 hourly jobs from 4,700. This will increase by an additional 1,100 as the Liberty successor, which will be produced in Toledo, is introduced for global distribution in the second quarter of 2013.

My dad never failed to remind us that a job is a about a lot more than a paycheck. It's about your dignity. It's about respect. It's about your place in the community. It's about being able to look your child in the eye and saying 'honey, it's going to be okay.'

... He credibly addresses men and women who otherwise aren't being spoken to in this election.

If Joe Biden is an angry old man, he's a lot like the angry old men who will swing this election.

The Town Hall where the questions voters want answered finally get asked

Then there's the Town Hall debate, where real people rather than a crusty old PBS host get to ask the questions. Chait thinks Obama will fail here because he'll spend time filleting Mitt rather than answering questions.

But one of the problems with the last debate was precisely in the stupid choice of questions Jim Lehrer asked.

I would expect that the questions from real people will be far more favorable

to Obama because the things voters care about provide Obama to describe where he has been successful and where the guy who brags about creating \$9/hour jobs he admits don't pay the bills tends to fail.

Plus, some of Mitt's biggest campaign gaffes have come when he responded to regular questions with douchbag answers—the "corporations are people" problem. Obama may be standoffish, but Mitt is standoffish and tone deaf when speaking with real people. And that, too, should serve Obama.

Then there's the foreign policy debate, an area where even Republicans recognize Mitt's weaknesses. Chait thinks this will go badly because it won't provide Obama an opportunity to talk about domestic issues.

And then the final debate centers on foreign policy. Obama can try to use some of the questions to turn to domestic policy, but that risks a scolding from host Bob Schieffer.

But unless Mitt pulls another total Etch-a-Sketch—even from the content of his speech today—he's going to say really stupid things, such as playing up Russia as our worst enemy.

More importantly, just about every foreign policy—except torture—that Mitt aggressively embraces is unpopular with voters. Mitt almost certainly will call for starting a new war, while Obama will claim (not entirely credibly) to have ended two wars. Even on trade, where Obama's championing of three new trade deals, Mitt could tack left of Obama, he

has chosen instead to accuse Obama of not supporting free trade.

I was right on the money on some points—Biden did use that same line from the debate. The questions from real people were better than the questions from moderators. Mitt looked pathetic when arguing that Iran has no access to the sea.

I was wrong about others: I apparently underestimated Mitt's willingness to etch-a-sketch on foreign policy. I underestimated how much both candidate would insist on discussing domestic issues in the last debate. I underestimated how pathetic Mitt's efforts to pander to his binders full of women would be.

But it's quite clear that every one of these debates was better than Obama's performance in the first one. By most measures, Biden and Obama won all three. And it's clear that that was partly because of the format. (And Raddatz, Crowley, and Schieffer were better than Lehrer.)

I make this point not to say I told Chait so. Rather, because the entire lefty twittersphere read Chait's essay and adopted it as convention wisdom. Why?

There was good reason after the first debate to observe that Obama tanked it, badly. But to suggest that Obama wouldn't be better in responding to real voters? In discussing foreign policy?

There were complaints after the first debate that Democrats didn't have as many hacks willing to lie about Obama's performance as the GOP has on their side. That has borne out.

But another part of the problem is Democrats' willingness to worry about poor analysis.
